Membership: We currently have 95 members total: 82 professional, 2 student groups, 7 students, 3 interns, 1 associate member.

We have dispersed 1 financial needs scholarship at the onset of the COVID-19 shutdowns, and 2 CMTE scholarships to members this quarter. While we have more scholarships and financial relief available at this time, no additional members have applied. We are moving into the new year with plans to increase our financial support scholarship and/or the number of applicants that can apply every year as well as reach out via social media so our members have regular reminders that such support is available.

Financials: IAMT, a 501(c)3 organization, is in good financial standing. We currently hold \$15, 951.21 total in our accounts.

Public Relations: We have hosted 2 virtual support meetings via Zoom since March open to both members and non-members in order to provide MT-BCs in the state with an opportunity to network and learn strategies from one another; areas of discussion included managing telehealth platforms, learning new technologies, managing financial needs, and telehealth intervention brainstorming. We had 15-25 attendees at each meeting.

IAMT also hosted a Virtual Social Meeting on Zoom in the summer, utilizing the platform to play games, engage in relaxation strategies, and shared our favorite recipes via a shared GoogleDoc. Our membership has shown us that these regular virtual meetings are helping them navigate this challenging time and we will continue to provide them after the holidays.

Student Relations: IAMT hosted a virtual student retreat attended by 30 students. Several MT-BCs presented on the topics of music therapy in psych settings, music therapy and childbirth, and the growing practice of telehealth.

Continuing Education: We hosted a virtual CMTE via Zoom in October: "Anti-Oppressive Practices for Music Therapists, hosted by Hayley Francis-Cann. Video playback was allowed for 2 weeks for those who registered but were unable to attend at that time, as approved by the presenter. We are in the process of planning for our Spring CMTE which will also be held virtually.

Task Force/Government Relations: Senate Bill 1198- Music Therapy Licensing and Practice Act is on hold due to the pandemic. Nancy Swanson is working to create a video about the proposed 2 tier license to educate the public and colleagues about the bill.

Clinical Training: Currently we have 10 listed national roster internship sites in Illinois; 9 of these sites are active and 1 is inactive. We are communicating with internship sites to update whether they are offering virtual options.

Archives: We digitally archived 3 file boxes of materials that are now available via a secure cloud log in for any future needs.

Meetings/Continuing Education: In 2020 we have offered one CMTE, a clinical songwriting course by Karen Miller, MM, MT-BC. This is currently being offered for free to members on our website through the end of 2020. In October 2020, we held a virtual conference for networking, our business meeting, a roundtable discussion on current needs in music therapy, and a student presentation on performance anxiety by Krista Cole, MT-BC. Our spring conference will be held virtually in March 2021. We are currently accepting proposals for CMTE presentations for this event.

Task Force and Government Relations: We have been keeping a close eye on Medicaid Waiver Redesign. We submitted a Public Comment on behalf of our state organization on June 15, 2020. We took the opportunity to approve of the overall direction toward more person-centered services and strength-based services. We asked that the state consider writing telehealth as an option in for Music Therapy services, increase the reimbursement for Music Therapy as it is quite a bit lower than the national average and we asked that the state reword our service definition to bring more clarity to the community.

We have also been very focused on Appendix K and the flexibilities being allowed for Medicaid waivers services within the state due to the pandemic. We continue to advocate for the telehealth option and attend all state webinars to advocate for Music Therapists and those receiving the service. Currently, those flexibilities expire on 12/31/2020, but the state has signaled that they will look to extend these flexibilities into the new year. The Indiana State Force has held two meetings since GLR, one in March and one in April. As a team, we decided to use our time to observe and record our "silver linings" from the COVID pandemic. We can use these to highlight and share with legislators in the New Year. We will regroup in January and make a plan for the 2021 legislative season. We are currently working on a potential bill for the 2021 legislative session.

Scholarship: Cheyenne Norris from the University of Louisville, who is currently an intern with Meaningful Day Services won the fall scholarships. January 31st is the last day to apply for the Spring scholarship.

Clinical Training: There are nine national roster internship sites listed on the AMTA website.

Social Event: We were unable to host a summer get together, so instead AIMT hosted a few events online in the fall. We have intervention shares, **Continuing Education:** We are currently working with CBMT to update our provider code. If you are in Indiana and would like to offer a CMTE, you are welcome to use our code.

2021: In March of 2021 a new executive board will take over. The elections are due to close in December.

Membership

Our 2020 membership (as of November 15) is 80 individuals. This includes 73 Professionals (67 professionals and 6 honorary lifetime) and 7 Students. There are also active student groups at both Western Michigan and Eastern Michigan Universities. To better engage students and encourage their involvement in MMT, we have started Virtual Meet a MT nights. These happen once a month and feature a music therapist from the state to describe their work and answer questions about the field. The first was held in October and was attended by 16 students!

Continuing Education

Our fall virtual workshop was a huge success. Thank you to Debbie Bates for presenting, and to the 52 members who attended our first virtual workshop.

Task Force

In August 2019, House Bill 4829 (music therapy licensure) was introduced by Representative Sarah Anthony (D). It was referred to the Regulatory Reform Committee. Our Hill Day, scheduled for March 24 at the state capital, was cancelled due to COVID-19. If the bill does not get passed by both the house and senate by the end of 2020, the bill will die and need to be reintroduced in 2021. The bill is not currently scheduled to be discussed.

MMT Memorial Scholarship

Applications for the Fall 2020 Memorial Scholarship were due November 1. However, the deadline was extended because there were no applications. The recipient has not yet been chosen.

Minnesota State Report – Stephanie Holman Hubbard

Membership: Current membership of the Music Therapy Association of Minnesota (MTAM) stands at 108 (82 professional members, 19 student members, 7 lifetime members) as of November 7, 2020.

Financials: MTAM, a 501(c)3 organization, is in good financial standing with a total of \$13,205.91 in assets (Checking - \$3104.42; PayPal - \$9596.49; Petty Cash - \$505). The Executive Board continues to update and adjust our budget based on our mission statement to aid us in financial tracking, planning, and decision making.

State conferences: MTAM completed our Fall conference series, consisting of two 2-hour workshops. Topics and presenters were Whiteness as a Source of Harm in Music Therapy Practice, Education, and Leadership, Presented by: Daniel Goldschmidt, MT-BC AND (Re)Centering Culture in Music Therapy, Presented by Natasha Thomas, PhD, MT-BC and Chantise Hunt, MA, MT-BC.

Conversations with local performing arts and humanitarian organization League Aires are currently on hold. League Aires expressed interested a longstanding partnership, granting MTAM \$5000-\$6000 annually in support of our conferences.

Awards: Congratulations to Sandra Holten, MT-BC and NMT Fellow for her Lifetime Achievement Award. In addition to serving her clients for over 37 years, Sandi has trained over 140 interns with Dawn McDougal Miller at Park Nicollet Health Services, has been an NMT fellow for over 20 years, serves on the NMT advisory council, and has contributed to music therapy organizations and education, as well as NMT and Parkinson's education and literature throughout her career. We held a congratulatory parade for Sandi on November 13, and were pleased to present her with her Lifetime Achievement award.

Scholarships: MTAM offers at least two \$300 professional scholarships three times per year with set deadlines. Scholarships can be used for professional development or advancement such as conference registration, membership dues, instrument purchase, or other needs. We were able to allocate grant funding and reallocate conference travel funding to award 5 professional scholarships this Fall.

This year, MTAM collaborated with our reimbursement committee in an effort to encourage our members to complete Waiver 101 training through the MN Dept of Human Services. We awarded two \$25 prizes to two of our 11 members who completed the training before October 31, 2020.

MTAM offers a \$300 internship stipend to at least two MN interns twice a year. In January, we had two applicants for our internship stipend, and offered two awards. Congratulations to recipients Shelby Smith and Claire Loritz.

In exchange for a report at our state conference, MTAM also provides financial support to the student MT organizations at the local universities to support their efforts to send their students to regional and national conferences.

Task Force: This Fall, the State Recognition Task Force has worked to monitor "special session" alerts from the capital as they may potentially affect our service users, worked with the Reimbursement group from MTAM as well as the MN Dept of Health to make adjustments to accommodate for the changes within the community. They also plan to reach out to former chief authors (who have been re-elected) to our former licensure bill to inquire about our next steps and gather information.

Other Business: This year, the reimbursement committee has worked tirelessly to advocate for waiver training for music therapists and led a grassroots effort to advocate for statewide waiver changes that could open music therapy services to over 7,000 Minnesotans. They established an email to act as liaisons with the MN Dept of Human Services: reimbursementliaisonmtam@gmail.com. Stay tuned for more info in 2021!

MTAM established racial equity goals, which will be ongoing. Our board's goals are to: actively engage in our own cultural humility education, prioritize conversations that isolate race and challenge whiteness, seek to provide various means of tangible support for BIPOC within our communities and profession, and prioritize thoughtful and careful provision of cultural humility-focused professional development opportunities for music therapists in our state.

MTAM established a COVID-19 response team. MN MTs, students, and interns self-assessed need for support in the following areas: Social/Emotional Support, Self & Community Care, Financial Support, and Tech Support. We held Zoom support groups weekly until June, shifted our Spring conference focus to self-care, and added a COVID-19 resource section to our website. We also increased member scholarships and continue to assess the needs of our members.

MN offered discounted student membership again this year, allowing half price membership for the month of February. There was increased student membership as a result.

In January, MTAM was awarded another grant from the Minneapolis Foundation, thanks to Ed Cannon from Zivix. This \$3000 grant allows MTAM to continue to offer student/intern members the ability register and attend MN conferences at no cost to them. In addition, the grant allows us to offer more support to our professional members, more robustly fund internship stipends, and continue supporting student organizations at the universities.

- 1. APAC has, as a primary task, to approve new programs and re-approve existing academic programs:
 - At the moment there are 91 approved programs in music therapy: 39 offer bachelor's and master's degrees, 49 are bachelor's only, and four are master's only. 10 programs also offer a doctoral degree.
 - To date, in 2020, two new bachelor's degrees and two new master's degree have been approved:
 - o BM, PB Equiv., University of Arizona, AZ
 - o BM, PB Equiv., Westfield St. University, CT
 - o MM, M-Equiv., Southwestern Oklahoma St. University, OK
 - o MA, Cleveland St. University, OH
 - Three new bachelor's programs and one new master's program are under review
 - Two reapprovals were granted for University of Miami and Maryville University
 - Two reapprovals are in process.
 - Overall for the year, APAC has reviewed 12 program applications for approval or reapproval.
- 2. Our committee work is year-round so we have adapted our meeting schedule and processes better address ongoing needs. We met online in the spring for COVID response and FAQ development as well as for subcommittee work and decisions on pressing topics throughout the year. We also met in the fall for preparation of materials for the Board of Directors and Assembly.
- 3. APAC has proposed 15 changes to the Standards of Education and Clinical Training. Some have been approved and others will be reviewed by the Board and brought to the Assembly this week. Highlights going into effect January 1, 2021 include:
 - Newly approved programs will be required to provide specific program updates after three years for the purpose of supporting new program directors and strengthening administrative support at the program level. Following this update, these programs will remain on schedule for the typical 10 year re-application 7 years later.
 - Distance learning guidelines were adjusted to improve transparency at both the program and course levels
 - Only a handful of programs have NASM and AMTA approval to offer distance learning. Any program desiring to remain online post-COVID will have an abbreviated application and will be responsible for maintaining those Standards in subsequent reviews. The current date for this requirement is June 1, 2021.
 - To aid transparency, AMTA Professional and/or Advanced Competencies mapped to a course are required to be shared on course syllabi
 - AMTA suggests an undergraduate student/faculty ratio of no more than 20:1 with a lower ration for program directors
- 4. We have proposed University Affiliated Internship Guidelines not unlike those for National Roster Internships. The purpose for these Guidelines will be to support program directors in knowing what structures to implement and support, to clarify roles for supervisors, and to provide clarity and protections for students.

- Task force chairs from each state successfully presented in a Round table discussion at the GLR 2020 Conference.
- States with legislative activity have sustained setbacks due to the COVID-19 pandemic and continue to move ahead despite challenges. See below for state-by-state details.
- Task force chairs and AMTA/CBMT staff hold regular strategy meetings

Below are the current legislative standings and other Gov. Relations activity for each state:

Illinois: Submitted by Nancy Swanson

The Task Force hosted an Advocacy event at the GLR Conference where they distributed 5 Champion of Music Therapy awards at the luncheon. Recipients included: Senator Laura Murphy-Chief Sponsor of our licensure bill, Susan Ruohonen-Lurie Children's hospital, Dr. Syliva Smith-Giant Steps Autism day school, Katrina Agnew-Season's Hospice, and Dr. Nina Kraus- Northwestern University: Brainvolts lab. The Task Force also hosted a Friday Advocacy breakfast event at the conference, inviting legislators, employers, music therapists, and IL university music therapy program heads.

IL is planning on send out a video to all MT-BCs in the next month or so re-explaining the two-tiered license proposed back in March. A follow-up advocacy Q & A will be held via Zoom.

IL Sept out "Good News" stories to Senator Murphy, chief sponsor, regarding telehealth music therapy during the pandemic

JL plans on refiling the licensure bill in the next legislative session.

Indiana: Submitted by Amanda Henley & Lindsey Wright

The Indiana State Force has held two meetings since GLR, one in March and one in April. As a team, we decided to use our time to observe and record our "silver linings" from the COVID pandemic. We can use these to highlight and share with legislators in the New Year. We will regroup in January and make a plan for the 2021 legislative season.

IN Government Relations: We have been keeping a close eye on Medicaid Waiver Redesign. I submitted a Public Comment on behalf of our state organization on June 15, 2020. We took the opportunity to approve of the overall direction toward more person-centered services and strength-based services. We asked that the state consider writing telehealth as an option in for Music Therapy services, as we have learned more about how to provide services in this way due to the pandemic and feel it does have a place in our service model. Secondly, we asked that the state consider increasing the reimbursement for Music Therapy as it is quite a bit lower than the national average. Finally, we asked that the state reword our service definition to bring more clarity to the community.

We have also been very focused on Appendix K and the flexibilities being allowed for Medicaid waivers services within the state due to the pandemic. We continue to advocate for the telehealth option and attend all state webinars to advocate for Music Therapists and those receiving the service. Currently, those flexibilities expire on 12/31/2020, but the state has signaled that they will look to extend these flexibilities into 2021. They continue to stress the importance of providers adhering to personcentered strategies rather than utilizing any blanket restrictions as that would conflict with the newer CMS settings rule. We will continue to keep up with any changes in Medicaid Waiver services as we all navigate through the pandemic.

Task Force members, including Amanda Henley met with legislators on Nov. 18, 2020 to discuss potential legislation in 2021.

Ohio Government Relations Synopsis: Submitted by Madeline Landry

- Participated in Zoom and conference calls with both the Ohio task force and the national team.
- Corresponded with the state task force and national team via email.
- Viewed recordings of the national team's zoom meetings.
- Updated the AOMT executive committee, and music therapists in Ohio as necessary.
- Viewed the live stream for our bill hearing (SB 238) during the month of September.

Michigan: Submitted by Kellee Coviak Hansen & Bernadette Skodack

A Hill Day scheduled for March 24th, which was "postponed" indefinitely due to COVID. The licensure bill continues to sit with the House Regulatory Reform Committee. Legislature has focused on little other than COVID. The legislative session will be ending at the end of 2020, but it is possible that bills may carry over into the next session due to COVID; we are in the process of getting some additional clarification about this. The Representative who sponsored the bill, Rep. Sarah Anthony, was re-elected to a second term.

Minnesota:

- The State Recognition Task Force (SRTF) began to monitor and track individuals currently in office that will be running again and those who have chosen to step down to aid in our action steps for the next hearing session.
- SRTF continues to support and work with the Reimbursement Group from the Music Therapy Association of Minnesota (MTAM) to address MN waiver reimbursement concerns
 - SRTF is monitoring "special session" alerts from the capital as they may potentially affect our service users.
- '• SRTF continues to work with the Reimbursement Group from MTAM as the MN Dept. of Health continue to make adjustments to accommodate for the changes within the community.
- SRTF continues to monitor the "special session" occurring at the capital.
- Elections are over, SRTF plans to reach out to former chief author's (who have been re-elected) to our former licensure bill to inquire about our next steps and gather information about what is happening on the hill.

Wisconsin: Submitted by Nancy Dexter-Schabow

- Continues to have the Music Therapy Registry.
- Gov. Relations team is meeting with a legislator in Nov. to discuss a licensure bill.
- In March, we successfully advocated for telehealth services for music therapy clients in the state. We had a little bit of help with clarification from a disability rights lawyer who had advocated with us for music therapy services in the past, which was very helpful in expediting an answer on telehealth from state agencies. We continue to advocate for the use of telehealth beyond the pandemic, as we are able to reach people in rural areas, and procure a better consistency in attendance, which helps clients move forward with their goals.
- It had been noted at telehealth- meetings with our Department of Health Services that music therapists in the state of Wisconsin had attained a high rate of success in working with clients via telehealth as compared to other Medicaid waiver providers.
- We are planning to host a virtual Hill Day in the spring of 2021. Details will be forthcoming.



GLR Special Projects

GLR Special Projects are a mechanism established by the Great Lakes Region for members to support clinical projects, research projects, or committee-related projects. Funding is available in two categories. Each fund has a specific purpose, protocol, and eligibility requirements.

- 1. The MUSE Fund (MUsical Instruments and supporting materials, clinical Services, Education)
- 2. Research Fund

The MUSE Fund

The MUSE fund is intended to support the needs of clinicians, the clinical use of music therapy within the CBMT Scope of Practice, AMTA Standards of Clinical Practice, and within the boundaries of the Professional Competencies of music therapists, and the advancement of GLR. Members of the GLR, including student members, can apply for funds to support the clinical use of music therapy including the purchase of musical instruments and supporting materials, the clinical training of the music therapist, clinical services of a music therapist, or one-time committee- related projects. The outcomes of projects supported by the MUSE fund are to be clinical or professional in nature. Data collection related to projects funded by MUSE is to be for the express purpose of enhancing the quality of music therapy service for the client or for advancement of the music therapy profession and not intended for research. Should data be collected for the purpose of presentation or publication, applicants should apply for Research funds.

Applicants are encouraged to apply for the MUSE funds to support various aspects of clinical practice and professional life as a music therapist. Examples of materials, education, and services include but are not limited to the following items: drums, iPad, Orff instruments, sign language course, fees for a clinical music therapist, parachute, one-time committee travel expenses, etc. Within the application, it should be made clear how the funds would be used and how the practice of music therapy would be enhanced by the funds.

Research Fund

Members interested in conducting music therapy research are encouraged to apply for the Research fund. Projects that are considered to be research are those that collect various types of data for the purpose of answering a research question that may or may not directly impact a specific client. These include master's theses, dissertations, and other studies where publication or presentation is the desired format for distributing results. All applicants proposing research involving human participants must have clearance by from an Institutional Review Board (IRB) or Human Subjects Review Board (HSRB). The GLR Executive Board will consider only those research proposals that have such a mechanism in place for the protection of human participants. Research that is approved by the GLR Executive Board will receive funding only after the applicant/researcher provides written proof of IRB/HSRB approval.

Research funding can be used to cover expenses related to research including but not limited to the following areas: travel costs, materials, testing measures, computer time, analysis support, instruments, clinical services for another music therapist, etc. Stipends for the primary researcher are not the purpose of this fund but will be considered in conjunction with other expenses and funding sources.

Dissemination of Results

If chosen for either the MUSE or Research award you will be asked to share the outcome information either through a concurrent session for the MUSE award or research poster submission for the research award. These presentations will be coordinated through the GLR President Elect. It is strongly preferred that these presentations occur at the GLR conference the following year from the date awarded. If the project is not complete or you need additional time please let the GLR President Elect know. You will be required to fill out a call for papers or research poster submission form, but no blind review is needed. If you would like to present in a different or additional format, a blind review will be required. Ouestions can be emailed to the GLR President Elect at glr.president.elect@gmail.com.

Submission Process

Applications for either fund are due to the President Elect 30 days before the GLR conference during which they will be considered. One MUSE and one research proposal may be funded at the GLR Regional Conference. Each project, regardless of the type, that is approved by the Executive Committee will be funded at an amount up to \$1,500. Applicants should do the following:

- 1. Submit full proposal via email; including:
 - 1. Completed Application (attached)
 - Project Narrative (3-page limit) that outlines complete details of your proposed project:
 - 1. Statement of need
 - 2. Detailed explanation of the project
 - 3. Project design
 - 4. Breakdown of funds request
 - 5. Timelines of project (Please include in your timeline above when you plan to share the outcome information with the GLR membership.)
 - 6. Any other information that you feel supports the need for the funding request
 - Additional copy of Project Narrative for blind review. Please remove any identifying
 information (name of music therapists, facility name, city, etc.) from this copy of the
 project narrative. This is the copy that will be shared with the GLR Executive Board
 members.

All items are to be Submitted in one email to the GLR President-Elect at <u>least 30 days</u> before the GLR conference. (glr.president.elect@gmail.com) Discussion and voting will take place during the GLR Executive Board meeting at the GLR conference. Applicants will be notified within 30 days after the GLR conference regarding the GLR Executive Board's decision.
