Membership

Our 2018 membership includes 53 Professionals, 40 Students, and 5 Lifetime members. We already have 11 members who have paid dues for 2019 membership. There are also active student groups at both Western Michigan and Eastern Michigan Universities.

Continuing Education

Due to hosting GLR, we did not offering a Spring 2018 workshop. On September 9, we hosted our Fall Workshop, entitled, "We Have a Bill... Now What?" It was led by the Michigan Music Therapy Task Force, and was attended by 15 professionals and 1 student.

We are reviewing ideas for our Spring 2019 workshop, as well as length of workshops, day that it's held, and the possibility of using technology to allow those who can't physically attend still participate.

Task Force

Our bill for music therapy licensure (HB 6197) was introduced on June 12, 2018 and referred to the House Health Policy committee. Due to summer and the recent election, we are still waiting for the bill to be addressed within committee. The bill is sponsored by Representative Thomas Albert from Lowell.

Membership

Current membership of the Music Therapy Association of Minnesota (MTAM) stands at 210 (94 professional members, 17 student members, 5 lifetime members) as of November 10, 2018.

Financials

MTAM, a 501(c)3 organization, is in good financial standing with a total of \$13,304.76 in assets (Checking - \$7058.73; PayPal - \$5497.53; Petty Cash - \$748.50) as of November 10, 2018.

State conferences

MTAM hosted two conferences in 2018 offering CMTE Credits: "Ethical Music Therapy Practice for the 21st Century" with Rachelle Norman in May and "Guitar Skills for Music Therapists: A Jenn Werner Stipend Fundraiser" with Peter Meyer, Jessica DeVillers and Destiny Boyum in October. The Fall conference was offered free to student members and all proceeds from this conference were allocated to a special stipend to offer assistance to MN MTs experiencing significant hardship in memory of Jenn Werner, a MN MT who passed away in 2016.

Awards

Af our October conference, we honored Dawn McDougal Miller with a Lifetime Achievement Award. Dawn has been a music therapy clinician for over 30 years, the internship director with Park Nicollet Health Services for 20 years and is also an instructor at Augsburg University. Jennifer Hicks received the MTAM Service award for her service to MTAM as our Public Relations Chair, creating the Instagram and Twitter accounts and expanding the social media reach of the MN association. Jenn also co-chairs the AMTA membership committee, and recently created an innovative private practice national roster internship program in collaboration with another music therapist.

Scholarships

In July, we awarded Emma Evans-Peck with a \$300 stipend as she completes her internship with Park Nicollet Health Services, serving patients in oncology, the Struther's Parkinson's center, and in-home hospice care.

The board has made significant changes to the way we will award scholarships beginning in 2019. Rather than smaller scholarships offered each month, we will award up to two \$300 scholarships three times per year. We have also streamlined our application process using google forms for online application submission. In addition, rather than offering individual student scholarships we will now be donating to the student organizations at each University to assist those student music therapy groups in sending members to regional and national conferences.

The Terrie Wolles McCoss Internship stipend offered twice yearly was also updated with a streamlined online application process and opening up the applicant criteria to any music therapy intern in MN, whether completing it in a National Roster site or University Affiliated site.

Regional Activities:

At the 65th Annual Conference of the Great Lakes Region - held April 9-15, 2018 at Eagle Crest Resort in Ypsilanti, MI - 3 Institutes and 9 CMTEs were offered for a total of 93 credits. During summer and fall 2018, GLR served as the approved provider for 4 CMTE offerings. In addition, the GLR CE representatives are currently working with the GLR 2019 Conference committee to obtain CBMT approval for conference CMTE offerings.

National Activities:

More than 1500 people attended the 2018 AMTA Conference in Dallas. 42 CMTE courses were offered at AMTA with over 550 participants. The CE Committee is working to unify continuing education practices across regions, which includes working towards utilizing technology for streamlining attendance reports and distributing certificates. The committee is also exploring ways to better share tasks for preparing and implementing the CMTE offerings at AMTA Conference.

The CE Committee Members presented a concurrent session at AMTA on Tips for Submitting Strong Presentation Proposals: Meet the AMTA Continuing Education Committee. This session shared an overview of what makes a strong proposal for selection at national and regional conferences and what components are reported to comprise a successful course. In addition, the CE Committee recorded a podcast with Cathy Knoll and created a supplementary guidebook on the session content; these materials will be available on the AMTA website.

Please be sure you are using measurable language when constructing your CMTE course objectives. If you have questions regarding how to properly do this, please utilize the Guidebook created by the CE Committee and/or contact the GLR CE Representatives for assistance.

Government Relations Report – Nancy Swanson

Illinois Government Relations/Task Force Report - Nancy Swanson, MA, MT-BC, IL Government Relations Chair/Task Force Chair Earlier this year, IL Senate Bill 2653 went from being a bill for licensure to a study bill called a Sunrise Review. This amendment was mostly due to heavy opposition from social workers. Senator Murphy, chief sponsor of Illinois' music therapy legislation, asked that the task force consider proposing a license for master's level, board certified music therapists only. She stated that focusing on the master's level music therapists would help to appease other professionals, namely social workers, who believe that our scope of practice is too extensive for a bachelor's level music therapist. We as a task force deliberated on this request and ultimately declined the idea since it would divide an already small group of music therapists in Illinois. As of 11.9.18, Senator Murphy reported that currently there is not enough legislative support of a Sunrise Review of music therapy, so she most likely will not call our bill in the Veto session happening the weeks of Nov. 12th and 26th. She stated that the Senate will only be calling bills that are time-sensitive in nature since there are so many bills waiting to be heard. The task force will communicate with Senator Murphy as to next steps for the 2019 legislative session.

Also, the task force sponsored an Advocacy Contest, where Illinois music therapists were asked to write letters and other forms of communications to their legislators. The task force would like to thank the organizations that provided amazing prizes for the contest: The American Music Therapy Association, The Illinois Association for Music Therapy, and Rachel Rambach with Listen & Learn. Unfortunately, there was limited participation in this contest with only one person earning a prize- K-Rae Knowles, who won a 2019 AMTA membership. The task force will discuss ways to improve this contest in the future.

In addition, another student advocacy contest was held for the two AMTAS groups at Western and ISU. Both schools submitted advocacy work and will each be reward with a \$75 pizza gift card donated by the Illinois Association for Music Therapy.

Indiana Government Relations/Task Force Report - Casey DePriest, IN Music Therapy Advocacy Task Force Chair AIMT and the Indiana Music Therapy Advocacy Task Force have been surveying Indiana agencies who employ music therapists to gather important information before we re-visit music therapy legislation during the next legislative session. We have been approached by Indiana art therapists and drama therapists about collaborating on legislation, however, we have not committed to doing so. We had strong support in the state house during out last attempt to pass legislation, but our bill was vetoed by then Governor, Mike Pence. With a new Governor in office and a Lt. Governor who was our previous bill sponsor in the House, we feel fairly confident about our chances of getting legislation passed this time around. We have also reached out to the ARC of Indiana for their support.

Michigan Government Relations/Task Force Report - Bernadette Skodak & Kellee Coviak Hansen, Tasks Force Chairs Michigan currently has a music therapy licensure bill- HB 6197 introduced on June 12th by Rep. Thomas Albert. It's been referred to the Health Policy Committee, where it's currently sitting. Michigan has a 2-year legislature, so if it doesn't get passed by the end of December (and we don't expect it to), we can re-introduce next year. Rep. Albert has been re-elected to the house. Senator Rebekah Warren, who attended our meet-and-greet event at GLR, was term limited in the Senate but was elected to the House, so she will continue to be a strong advocate for us. Michigan also held an advocacy training CMTE on September 9th in Lowell, which is the home district for Rep. Albert.

Minnesota Government Relations/Task Force Report - Ericha Rupp and Todd Schwartzberg

We are working with our current chief author Sen. Jerry Newton in crafting a new licensure bill for the next session. After the mid-term elections our past chief author from the house was unseated. In result we are in the midst of gathering information to search for a new chief author. At the same time we are continuing to communicate with the state association for Speech-Language Pathologists (MNSHA).

Ohio Government Relations/Task Force Report - Erin Spring and Ed Gallagher: Co-Chairs of the Ohio Music Therapy Task Force

- ► A Music Therapy Hill Day was held in February of 2019 an the day included:
 - The day started with a session concerning advocacy led by members of the Ohio Task Force and Erin Hoppe, from VSA Ohio.
 - 30 elected official from the Ohio House and Senate and/or their aides.
 - They attended a luncheon that included presentations and videos from music therapists, supportive interested parties and parents of music therapy participants.
- The Legislation language was drafted and approved by the Ohio Music Therapy Task Force (OHMTTF) and AMTA/CBMT in March 2018.
- Task Force Chairs and Senator Yuko's Office met to develop a plan for moving forward and scheduling an Interested Parties Meeting.
- An interested parties meeting was held at the Ohio Statehouse on May 16th. In attendance were:
 - Senator Kenny Yuko along with three legislative aids his office.
 - Members of the Ohio Task Force
 - Two national music therapy task force members (via phone)
 - A pro-music therapy licensure Speech Language Pathologist and Attorney
 - Representatives from Speech & Audiology, Physical Therapy, Occupational Therapy, Counseling & Social Work
 - Concerns and suggestions were discussed in the following categories: Scope of Practice, Education & Training, Reimbursement & Oversight.
- Task Force Chairs met with Senator Yuko's legislative aids on May 30th to collaborate and identify improvements that could be made in the drafted bill based on the input received in the IP meeting.
- Items were addressed throughout the summer and early fall with final language being approved by the OHMTTF, AMTA/CBMT and Sen. Yuko
- It was decided by Sen. Yuko that the bill would not be introduced during this General Assembly time period which concludes on December 31. Instead it will be introduced at the beginning of the next session which runs from January 2019 through December 2020. Sen. Yuko was recently re-elected and it is expected that he will retain his minority leadership role in the Ohio Senate.
- In 2019 we will kick off a campaign to encourage visits by elected official as we head into the bill language being introduced.

In other GLR news, the State Recognition Task Force chairs submitted two proposals for the 2019 GLR conference: One is a task force roundtable and the other on advocacy. We are waiting to hear if the proposals were selected.

First, thank you to everyone who was asked to complete the reimbursement survey this year! Due to the information we were trying to gather with the survey, it was only sent out to a specific group of practitioners who could provide specific information about how they are reimbursed. A team will be analyzing the data and the results should be available by early 2019.

There is now a section on the AMTA website for Reimbursement information! Under the Member Resource section, you will soon be able to find such resources as a CPT Code Fact Sheet, webinars from Reimbursement Committee members, and one-page overviews of specialized funding topics, such as Worker's Compensation, "Incident-To" billing, and Prompt Pay Discounts.

Reports of reimbursement successes through different private and public third party payers have been positive overall, but rates and sources of reimbursement vary by state. If you are having any success with billing to insurance or other third party payers, please contact me with the details so we can stay current.

Federal regulation and Executive Order changes to the Affordable Care Act have the potential to limit access to services that were originally guaranteed through the ACA. The national office staff are monitoring these changes and are collaborating with Washington-based coalitions to advocate for continued coverage of essential health benefits and pre-existing conditions.

Finally, in 2019, the Reimbursement Committee will start looking into outreach opportunities to different academic programs in all regions to offer live or virtual trainings in different reimbursement topics and processes. More information to follow.

Special Projects

Special Projects

Special Projects is a mechanism established by the Great Lakes Region for members to support clinical projects, research projects, or committee-related projects. Funding is available in two categories: the MUSE Fund (MUsical Instruments and supporting materials, clinical Services, Education) and the Research Fund. Each fund has a specific purpose, protocol, and eligibility requirements.

The MUSE fund is intended to support the needs of clinicians, the clinical use of music therapy within the CBMT Scope of Practice, AMTA Standards of Clinical Practice, and within the boundaries of the Professional Competencies of music therapists, and the advancement of GLR. Members of the GLR, including student members, can apply for funds to support the clinical use of music therapy including the purchase of musical instruments and supporting materials, the clinical training of the music therapist, clinical services of a music therapist, or one-time committee-related projects. The outcomes of projects supported by the MUSE fund are to be clinical or professional in nature. Data collection related to projects funded by MUSE is to be for the express purpose of enhancing the quality of music therapy service for the client or for advancement of the music therapy profession and not intended for research. Should data be collected for the purpose of presentation or publication, applicants should apply for Research funds.

Applicants are encouraged to apply for the MUSE funds to support various aspects clinical practice and professional life as a music therapist. Examples of materials, education, and services include but are not limited to the following items: drums, iPad, Orff instruments, sign language course, fees for a clinical music therapist, parachute, one-time committee travel expenses, etc. Within the application, it should be made clear how the funds would be used and how the practice of music therapy would be enhanced by the funds.

Members interested in conducting music therapy research are encouraged to apply for the Research fund. Projects that are considered to be research are those that collect various types of data for the purpose of answering a research question that may or may not directly impact a specific client. These include master's theses, dissertations, and other studies where publication or presentation is the desired format for distributing results. All applicants proposing research involving human participants must have clearance by to an Institutional Review Board (IRB) or Human Subjects Review Board (HSRB). The GLR Executive Board will consider only those research proposals that have such a mechanism in place for protection of human participants. Research that is approved by the GLR Executive Board will receive funding only after the applicant/researcher provides written proof of IRB/HSRB approval.

Research funding can be used to cover expenses related to research including but not limited to the following areas: travel costs, materials, testing measures, computer time, analysis support, instruments, clinical services for another music therapist, etc. Stipends for the primary researcher are not the purpose of this fund, but will be considered in conjunction with other expenses and funding sources.

Applications for either fund are due to the President Elect 30 days before the conference (GLR or AMTA) during which they will be considered. One project can be funded at the annual AMTA Conference, and one project may be funded at the GLR Regional Conference. If no project is funded at the AMTA Conference, then, two projects may be funded at the GLR regional conference. Each project, regardless of the type, that is approved by the Executive Committee will be funded at an amount up to \$1,500.

SUBMISSION PROCESS:

- 1. Complete Special Projects Fund Application (on the next page) and use it as a guide in creating your proposal.
- 2. Submit completed cover letter with your full proposal. Submit to the GLR President-Elect at least 30 days before a GLR or AMTA conference.
- 3. Submit a separate document for blind review. In this copy, please do NOT include the cover letter. Also, please remove any identifying information (name of music therapists, facility name, city, etc.) from the proposal. Submit to the GLR President Elect at least 30 days before a GLR or AMTA conference. This is the copy that will be shared with the GLR Executive Board members; discussion and voting will take place during the GLR Executive Board meeting at the next conference (GLR or AMTA).
- 4. Applicants will be notified within 30 days after a GLR or AMTA conference regarding the GLR Executive Board's

DEADLINE FOR APPLICATIONS: 30 days before GLR or AMTA conference.

Special Projects Fund Application

Special Projects is a mechanism by the Great Lakes Region for members to support clinical projects, research projects or committee-related projects. Funding has been used to cover some expenses related to travel costs, materials, testing measures, or computer time. Funding is typically not approved for stipends. Funding is available in two categories: the MUSE Fund

(Musical Instruments and supporting materials, clinical Services, Education) and the Research Fund. Each fund has a specific purpose, protocol, and eligibility requirements. Persons interested in any type of research or conducting a project directly related to clinical practice are encouraged to apply.
