Job Description: COMT is looking for a highly motivated, energetic, and compassionate person who is interested in providing licensed and board-certified music therapy in accordance with AMTA and CBMT standards. Music therapists are required to have the Music Therapist-Board Certified certification and LPMT. COMT provides music therapy services to a variety of client populations in a variety of settings. The Music Therapist’s duties include:

- Reviewing client intake documents and appropriately communicating with administrative assistant/executive director regarding referral contacts or new clients;
- Communicating with client family and other interdisciplinary team members;
- Providing appropriate detailed client assessments with formalized written reports;
- Developing music therapy treatment plans and providing direct music therapy services to COMT clients and contracted agencies through individual, group, and co-treatment, focusing on goals and objectives;

- Completing weekly progress notes, quarterly progress reports, client attendance record/therapy logs, and/or documenting within company wide HIPAA compliant electronic documentation systems;
- Providing supervision to undergraduate and graduate music therapy students and COMT intern.
- Actively seek best practice through participation in continuing education opportunities and writing for the COMT research blog; and
- Attending COMT staff meetings, participating in company supervision opportunities, presenting in-services and attending community events as a representative of COMT.

The Music Therapist will report to Central Ohio Music Therapy's Executive Director, their supervisor and the Director of Operations. COMT will provide The Music Therapist with music therapy materials and equipment necessary to adequately complete all job tasks.

Potential Client Populations: Child/Adolescent Psych (individual and group) and Child/Adolescent with ASD.

Qualifications: The Music Therapist-Board Certified must hold and provide a copy of their current MT-BC certification and Ohio Music Therapy License. The therapist may also be required to submit background checks, health records, participate in drug testing and other health and safety related documentation as necessary to participate in a variety of work sites.

The Music Therapist must hold a valid driver's license and have reliable transportation as well as auto insurance, as the position requires some travel on a weekly basis. Due to the travel involved with this position, it is preferred the therapist reside in or around Athens, OH.

The music therapist must work well in multiple team-oriented environments and have an interest in developing new programs. Strong organization and open communication skills are necessary.
